Refund policy

Revised 3-18-08

This policy applies only to participants who paid money directly to Polarity Healthcare, Valley Massotherapy or Randall Gibson.

One-Day Seminars (or shorter)

1-A. The entire tuition is refundable up to 7 days prior to the seminar.

1-B. If you are unable to attend and notify us less than 7 days but, at least 24 hours prior to the seminar, the tuition is refundable minus a \$25 administration fee, or you can apply the full amount as credit toward a future seminar. If applied to a future seminar, a minimum of \$25 will remain non-refundable.

1-C. If you cancel within 24 hours of a seminar, tuition is non-refundable. You may (one time only) apply the entire tuition amount to a future seminar. If you cancel within 24 hours a second time, administration fees apply.

1-D. If you (with no notification) do not show up for a seminar, tuition is non-refundable. You may apply the tuition amount (minus a \$25 administration fee) toward a future class.

1-E. If you attend only part of a seminar, no refund is available. You may be permitted to attend a part of the class which you missed when the class is offered at a future date.

Two-Day Seminars (or longer)

2-A. The entire tuition is refundable up to two weeks prior to the seminar.

2-B. If you cancel less than two weeks but, at least, 24 hours prior to the start of a seminar, the tuition is refundable minus a \$50 administration fee, or you can apply the full amount as credit to a future seminar. If applied to a future seminar, a minimum of \$50 will remain non-refundable.

2-C. If you cancel within 24 hours of a seminar, tuition is non-refundable. You may (one time only) apply the entire tuition amount to a future seminar. If you cancel within 24 hours a second time, administration fees apply.

2-D. If you (with no notification) do not show up for a seminar, no refund is available. You may apply the tuition amount (minus a \$50 administration fee) toward a future class.

2-E. If you attend only part of a seminar, no refund is available. You may be permitted to attend a part of the class which you missed when the class is offered at a future date.
